

## American Rescue Plan Act of 2021: Billions\$\$ for Indian Country

America Rescue Plan Act (ARPA) provisions that reference funding and benefits for Tribes and Tribal entities.

- Justice40 Initiative (J40I)

In Executive Order 14008, the President directed the Director of the Office of Management and Budget (OMB), to jointly publish guidance on how certain Federal investments might be made toward a goal that 40 percent of the overall benefits of such investments flow to disadvantaged communities – the Justice40 Initiative. This interim guidance includes a set of actions required of agencies that manage covered Justice40 programs. These actions include identifying the benefits of covered programs, determining how covered programs distribute benefits, and calculating and reporting on reaching the 40-percent goal of the Justice40 Initiative.

  - Economic Adjustment Assistance: \$500M
  - Good Jobs Challenge: \$500M
  - Indigenous Communities: \$100M
